COVID-19 Updates:

Dear Bayview Community,

The leadership team became aware of a resident in Assisted Living who has tested positive for COVID-19 on Saturday night 2/12/22. We were waiting for all results to be processed before announcing the positive case to the community. Individuals were immediately contacted. **This brings our total active cases to 1 within the building.**

The affected resident is asymptomatic and is recovering well. With this active case occurring in Assisted Living, Assisted Living second (2nd) and third (3rd) floors, and Memory Care are considered in an Outbreak status.

With no further cases, the current quarantine in Assisted Living and Memory Care will last through 2/23/22, with the Outbreak potentially ending on 3/9/22. It is strongly recommended you avoid passing through or walking in this area until further notice. For more information contact the appropriate staff at the end of this memo.

The most current King County rate of infection is 1,163.7 per 100,000 people as of 2/1/22. With the continued decline of rates of infection and the effectiveness of our test-based strategy, please see the following loosening of restrictions.

VISITATION

Independent Living:

Effective immediately: Visitation for Independent Living is open without any cap in number of guests visiting at a time, including children. As a reminder, visitors must wear a facemask at all times and properly screen at reception. Visitors should move directly to and from the visiting apartment only and are not allowed in public areas. Visitors must continue to abide by the governor's proclamation, and unvaccinated visitors (including children), may not visit indoors with an unvaccinated resident.

Regulated areas (Assisted Living, Memory Care, Skilled Nursing):

Scheduled visitation for regulated areas continue to follow the Department of Social and Health Services "Safe-Start for Long Term Care Guidance" and are for Essential

Support Persons (ESP) and Compassion Care Visits (CVVs) only. Please contact the appropriate staff member to schedule your visitation with a loved one (contact information is located at the end of this memo).

DINING SERVICES FOR INDEPENDENT LIVING

Effective Monday, February 21st: The Terrace Garden Main Dining will begin it's gradual reopening for **lunch only**. With dining services continuing to experience staffing shortages, we are positioning ourselves to open in measured phases over the next few weeks. We have hired new staff and are excited about the direction in filling most of our open positions. We do anticipate opening for dinner soon as new employees are trained. Below are the hours and services offered beginning this Monday, February 21st. We will keep all our residents informed as we transition to the next phase.

Breakfast: Room Service only.

Lunch: Dining Room open 12pm-2:00pm Daily. Room service will still be offered for those wishing to stay at home.

Dinner: Room Service only

Please note that there will be **no delivery room service fee** charged at this time.

THRIVE FITNESS CENTER & POOL

Independent Living:

Effective Monday, February 21st: Fitness programming and classes will begin. The use of the fitness center will also no longer require sign-ups. Please remember to wear your mask and social distancing will be in effect at all times. The use of the pool will still be by sign-up only. Please remember the use of the fitness center and pool is test-based only (you must test negative for COVID-19 prior to use). More details to come in the Weekly newsletter.

Regulated areas (Assisted Living, Memory Care, Skilled Nursing):

Due to the current outbreak status, Thrive Fitness Center & Pool are currently suspended at this time for Assisted Living residents and will potentially open up by 3/9/22 (end of the outbreak status).

VAN SERVICES

Effective March 1st: Van Services will be open to excursions and shopping trips (i.e. Fred Meyer, Trader Joes, Safeway) in addition to medical trips. The Life Enrichment

team will be working the transportation team and Excursions Committee to review the March Van calendar. More details to come.

ELEVATOR CAPACITY

Effective Immediately: The capacity for the large elevator in the tower building will increase to 4 people. Please note the small elevators in both the tower and terrace buildings will remain at 2 people. Elevator Signage will be printed as friendly reminders.

REMINDERS: >>

PLEASE REMEMBER ALL PROGRAMMING, MEETINGS, ACTIVITIES, AND THE USE OF THE FITNESS CENTER AND POOL ARE TEST-BASED ONLY, WITH TWICE WEEKLY TESTING. COVID-19 TESTING IS ON SITE IN THE KINNEAR THEATER MONDAYS AND THURSDAYS FROM 8 AM – 3:30 PM.

PROGRAMMING & ACTIVITIES:

- **Independent Living:** Capacity limits for activities, meetings, and programs are dependent on the size of the room or space and masks must be worn at all times. Please ensure social distancing is possible at all times.
- **Regulated areas (Assisted Living, Memory Care, Skilled Nursing):** Due to the current outbreak status, programming for regulated areas have been curtailed, in accordance with the Department of Social and Health Services Safe-Start for Long-Term care guidance.

ALL THE BUZZ HAIR SALON: The salon is currently open for scheduled appointments.
